## Norfolk County Council TEMPORARY TRAFFIC REGULATION ORDERS 2023 (NORWICH) Road Traffic Regulation Act, 1984

Norfolk County Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984, hereby give notice that:

(i) THEY PROPOSE TO MAKE Temporary Traffic Regulation Orders in respect of the following roads:

**CAMBRIDGE STREET -** from its junction with Unthank Road to its junction with Rupert Street to facilitate lead communication pipe replacement works from 18<sup>th</sup> September to 27<sup>th</sup> October 2023. Alternative route is via: Unthank Road, Essex Street, Vauxhall Street, Norfolk Street, Union Street, Cambridge Street.

**REDWELL STREET -** onto St Andrews to facilitate electrical connection works. The road will be temporarily subject to a no right turn restriction from 18<sup>th</sup> September to 27<sup>th</sup> October 2023. Alternative route is via: Bank Plain, Agricultural Hall Plain, Prince of Wales Road, St Vedast Street, Rose Lane, Market Avenue, Agricultural Hall Plain, Bank Plain and St Andrews Street.

**WILBERFORCE ROAD -** from its junction with Bridge Farm Road for 70m south-eastwards to facilitate communications upgrade and maintenance works between 08:00 and 16:30 on 22<sup>nd</sup> September 2023. **Please note that these dates replace any previously advertised dates in respect of this location.** Alternative route is via: Wilberforce Road, Earlham Road, Earlham Green Lane, Malbrook Road, Wilberforce Road, vice versa.

(ii) THEY HAVE MADE Temporary Traffic Regulation Orders in respect of the following roads:

**CONCORDE ROAD** - from 130m southeast of its junction with Spar Road for 30m southwards to facilitate electrical cable installation works from 12<sup>th</sup> to 18<sup>th</sup> September 2023. Alternative route is via: Concorde Road, Vulcan Road South, Spar Road and vice versa (Norwich, Hellesdon).

**HEARTSEASE SCHEME – 1) Harvey Lane** from its junction with St Williams Way/Plumstead Road Roundabout for 48m southwards; **2) Plumstead Road East** from its junction with St Williams Way/Plumstead Road Roundabout for 30m north eastwards; **3) Margetson Avenue** from its junction with St Williams Way for 20m southwards; and **4) Plumstead Road** into the ALDI superstore carpark to facilitate works for the Transforming Cities Scheme. The roads 1, 2 and 3 will be temporarily closed (except for access) and the no right turn restriction at road 4) will be temporarily suspended from 11<sup>th</sup> September 2023 to 24<sup>th</sup> April 2024. Alternative route is via: 1) Harvey Lane, Yarmouth Road, Thunder Lane, St Williams Way and vice versa; 2) Plumstead Road East, Woodside Road, Salhouse Road, Heartsease Lane and vice versa; and 3) Margetson Avenue, Gordon Avenue, Pilling Road, St Williams Way and vice versa.

**NEWMARKET ROAD SCHEME (PHASE 2) -** from its junction with Daniels Road roundabout to its junction with Albamarle Road to facilitate Transforming Cities Scheme surfacing works between 20:00 and 06:00 from 11<sup>th</sup> September to 6<sup>th</sup> October 2023, only while signs indicating the closure are in place. Alternative route is via: Daniels Road, Ipswich Road, St Stephens Road, Newmarket Road and vice versa.

**VERA ROAD -** from its junction with Boundary Road for 65m northwards to facilitate utility cover repair works between 19:00 on 14<sup>th</sup> and 06:00 on 15<sup>th</sup> September 2023. Alternative route is via: Vera Road, Merchant Way, Reepham Road, Cromer Road, Boundary Road and vice versa.
